(George) PROGRAM – Santa Barbara County Surveyor, Aleks Jevremovic

-Plans in place to start accepting electronic submittals of maps rather than mail.

-The County will be re-scanning the record maps in high resolution color scans for better quality from both your work station and cell phone.

-Santa Barbara County Surveyor's Office to go full cost recovery, possible hourly costs for Record of Survey reviews. This would add a significant cost to the map review fees as they currently are only recovering about 15% of costs on Record of Survey reviews. The Board of Supervisors meeting to discuss this will be either February or March with changes coming into effect possibly in July.
