#### President Elect-Kevin Hills

• Chapter mentorship: Each chapter now has a State Mentor. The Central Coast chapter is part of Division 3 with Joseph Padilla-CLSA President-Elect- this mentor is to remain until he is not an officer.

• BOD meeting to be relocated due to unsafe conditions in the area

## **Executive Director's Report:**

- 2024 PLS Act/SMA will be moved to download format. No more CDs!!!
- To sponsor a student or door prizes go to plseducation.org
  - Student sponsorship is now \$500 each not \$350 as in previous years. They decided to raise the amount after revising how much CLSA was paying for each student and the cost has increased in the last years.
- CAL SURVEYOR won the NSPS Excellence in Journalism-Best State Society Magazine for the Spring 2022 issue.
- Reinstatement and entrance fees are now both \$25 rather than \$15 and \$25 to simplify the process.
- Donations paid online while renewing your memberships are now tax deductible.
- PLS review 2012 is now \$100 for members and \$200 for non-members

#### Lunch Discussion:

• Joe Padilla encouraged the chapter to contact Michael Butcher to add at least one member to the legislative committee to have an early say on any proposed changes/bills. This was proposed after Joe Morris asked regarding the origin of the proposed 8771 language.

#### Legislative Committee

- CLSA sponsored bills regarding monument preservation, online maps
  - Review fee for Record of Survey. (This was approved at the November 4, 2023 Board of Directors Meeting. See pages 8 and 42 of 73 of our Feb. 3 agenda packet.) Mike Belote thinks this might require County General funds to make this happen, and if it does, then the Counties might oppose it. Chapters are encouraged to reach out to Counties and try to convince them this is a good idea.
- Orange County Director Brian Mundia met with Rick Moore and Dallas Sweeny to discuss the 8771 language. Their comments have been received and will go back to Legislative Committee for review.

• Dave Woolley, asked for members to read Labor Code 1720-surveying is listed as a trade not as a profession because of prevailing wage which means low bid wins not QBS, this is a big problem according to him because it is based on what you do, and not your title. Land surveying can't be in the Labor Code and QBS, it can only be in one.

#### **Education Division:**

- Trig Star membership had been paid by CLSA
- CLSA will be sending a letter supporting Santiago College's 4-years online surveying program, the chapter voted in favor of supporting this program. This program is not ABEP accredited.
- The education committee is looking for donations for the silent auction-anything helps, instruments, books, instruments, etc.
- CLSA will have a raffle at their conference booth. 2 items-\$5 a ticket. Items to be determined
- CLSA is sponsoring 2 students to the conference
- The Board of Directors approved the Advanced Technologies Committee to plan 3 webinars sponsored by CLSA.

## Membership Division: CAL Surveyor

The board approved a cost of \$3000 to add another 16 pages to the CAL SURVEYOR due to how thin the latest issue was. The editor also encouraged members to submit any articles they might want published.
